TRAINING CONTRACT

- Board is due on receipt. Outdoor paddock board is \$475 + gst. Indoor boxstall is \$600 + gst per month.
- Training fees are due in full on the last day of every month made payable to CR Equine services. \$500+GST
- Training is based on a 5 day training week. Horses turned out daily.
- All balances must be paid in full upon receipt or will be subject to a finance charge of 10% per month. NSF Cheques will be assessed a \$25 fee.

ADDITIONAL CHARGES

- All training horses are required to be on a 6 week shoeing and/or trimming schedule provided by Rocky Turel and will be billed accordingly.
- All training horses are required to have regular immunizations and deworming and will be billed accordingly.
- Blanket washing and repairs will be added on your training bill.

***Please provide your horse with the necessary winter blankets or summer sheets.

LESSONS

If horse(s) is in full time Training Christa Turel will offer 1 free lesson per week. These lessons are not cumulative and must be used while having a horse in training. Horse other than the one in training may be used if horse in training is not ready or suitable for owner at that particular time.

\$60 Private lesson

\$45 per person in a group of 2 or more riders

\$500 for a pre-purchased package of 10 lessons to be used within one calendar year.

SHOWING

Christa and the client will determine the training horses show schedule. Once the show schedule is determined, Christa will fill out the entries for your horse and return it to you. You will receive a completed entry form which will include classes entered, stall, paid warm-ups, as well as the necessary memberships that are needed. You will be responsible for submitting completed entry form along with applicable attachments (registration papers ect...) and payment to applicable show secretary before entry deadline.

ADDITIONAL SHOW AND TRAVEL EXPENSES

- Hauling at \$0.45per km(Rate is subject to change according to rising fuel prices) minimum \$50 charge
- Hotel, feed/tack stalls will be divided equally by total number of Horses I have at the show including Non Pro Horses.
- Show fees are \$40 per day per horse while at the show.
- Prize money –Money won minus the class entry fee split 50/50 between Christa Turel and owner of the horse.
- All prizes are retained by the owner. Buckles goes to Christa Turel. (This is Negotiable)

SALES

Christa Turel will advertise horse on CR Equine website and will assist with marketing. Any additional ad campaigns will be billed to the owner. All owners will be assessed a 10% commission fee if horse is sold while in the care of Christa Turel reining horses.

TRAINING AGREEMENT

I, _____ have read the Training Contract and I am fully aware of the possibility of potential injury that may occur in the training of my horse even though all necessary precautions will be taken. Christa Turel and all employees and owners of CR Equine Services assume no responsibility for accidental injury that may be occurred while your horse is in training and being boarded at CR Equine Services.

While my horse is in training, I agree to pay all incurred costs including Farrier work and vet bills. You will be notified if your horse is in need of emergency care but if you are unable to be reached a veterinarian of our choice will be called at the owners expense. All training fees and board are due on the last day of every month made payable to CR

Equine Services.
